Returns

Before returning any goods for any reason, a valid returns authorisation number must be obtained from WEL Medical Ltd. You may return any product for a full refund within 7 (seven) working days of delivery providing that it is in perfect resalable condition. Your refund will include the full value of the order including the cost of carriage from us to you. We will be happy to arrange for a carrier to visit your home/premises and collect any returns but will pass the cost of this onto you.
