

Minutes of the Parish Council meeting which followed the APM

held on Thursday, 7 April 2022 in the Village Hall at 7.45 pm

Present: Councillors Clark (SC in the Chair), Emmison (BE), Smith (MS), Gregory (JG), Haynes (CH), Robinson (KR), Wilkinson-Mudd (MWM) and Dexter (GD).

Declaration of interests on any item to be discussed: None.

Minutes: to approve the minutes of the last PC meeting held on Thursday, 24 February, proposed to be a true record by JG, seconded by MS and carried. To approve the minutes of the Planning/Finance meeting held on the 17 March, proposed to be a true record by BE, seconded by JG and carried.

Plans:

Mr. O. Fielder, Land N of 92 Barmby Road – erection of a dwelling (custom build) (All Matters Reserved) (**Ref: 22/00762/OUT**). After a long discussion members decided to submit the same objection previously submitted on this site. **Proposed by GD, seconded by CH and carried unanimously:**

Barmby Moor Parish Council object strongly to this proposed housing development for the following reasons:

1. The proposed development is in an area not designated for housing development and East Riding of Yorkshire Council removed this site from building allocation for the East Riding Local Plan;
2. East Riding Local Plan 2012 - 2029 states the gap between Pocklington and Barmby Moor serve an important role in maintaining the individual characters of the settlements by preventing coalescence and Policy A6: Vale of York sub area - C. Environment - Clause 8 of the Local Plan states that "Plans, strategies and development decisions in the Vale of York sub area should maintain the physical separation of Pocklington and Barmby Moor";
3. In the preparation of the Barmby Moor Development Plan, of 191 responses to the Development Plan Questionnaire 174 (90%) agreed that the physical separation of Pocklington and Barmby Moor is important and should be maintained;
4. This proposed development along B1246 would be the start of coalescence between Pocklington and Barmby Moor. It is contrary to Policy A6:C.8 of East Riding Local Plan 2012

and against the wishes of the residents of Barmby Moor who agree that the physical separation of Pocklington and Barmby Moor is important and should be maintained;

5. The Gliding Club is an important asset for this area, both for leisure and tourism. Barmby Moor Parish Council requests that full consideration is given as to the effect that this proposed development may have on the ability of the Gliding Club to maintain its operations and its existence.

Barmby Moor Parish Council request that this application goes to Council when deciding this application.

Approval: Mr. J. Farrow, The Firs, York Road, erection of outbuilding containing stables, back room and straw store (retrospective) – (Ref: 22/00286/PLF).

Pocklington Provincial Councillors report: email sent with apologies for this meeting.

EV Charging points – the cost will be £4000 per point.

Adults “your life your way.uk” – is aimed at residents to maintain active and independent lives.

2 year halt to road resurfacing – ER will have to concentrate on patching roads and potholes. This is the result of the war in Ukraine and Russia where tar is sourced. This is increasing prices and availability.

Matters arising from previous meetings:

Traffic Management – SC, BE, KW, PW and the clerk attended a 2 hour meeting held on Wednesday, 6 April, 2022. A member of the CSW Team (Janet Britton) also attended. Nicola Moger of Traffic Management and a Highways Engineer gave an excellent input which looks promising but it will take a few weeks for a report and proposals to be forwarded for traffic calming measures in the parish. Members suggest once received to involve the School for the Flat Lane and school traffic issues.

Queens Platinum Jubilee Celebrations – successful grant application of £500 from ERYC Jubilee Fund. Clerk to complete a grant acceptance form. Clerk asked if the PC will be purchasing a seat to commemorate the Queens Jubilee. Members suggested an ideal place for a seat would be next to the Cremated remains area, will discuss at the next meeting.

Projector and screen in Village Hall – quotation received + costs for installation, approved by the Village Hall Committee. Members agreed to go ahead with the purchase which will benefit the VH and PC and users of the Village Hall. Clerk to get final estimate.

Any other business for future meetings:

Western Parishes meeting – BE confirmed next meeting is in June, if anything needs raising please pass on.

A1079 litter picking –to put on the Agenda for the next meeting.

Endymion Cottage – KR mentioned the hedge needs cutting back again due to vision obstruction for vehicles leaving SL.

Keldspring Lane – GD mentioned a section of the watercourse bank looks ready to collapse.

Ashcourts – sand and dust in the watercourse.

Potholes – members reported pothole repairs around the village.
