Minutes of the Parish Council meeting held on Thursday, 16 May 2024 at 7.45 pm in the Village Hall, Barmby Moor (after the Annual General Meeting)

<u>Present</u>: Councillors Clark (SC in the Chair), Haynes (CH), Gregory (JG), Britton (JB). Pocklington Provincial Councillor Needham (DN).

<u>Apologies</u>: Received from Councillors Appleton, Tindell, Dexter and Emmison.

<u>Declaration of Interest from members on any item to be discussed:</u> None.

<u>Minutes:</u> to approve the minutes of the PC meeting held on the 18 April, proposed to be a true record by JG, seconded by JB and motion carried.

Clerk's report:

Grit bins – once the new bank account has been completed, the clerk will purchase the two grit bins.

Unauthorised Encampments – the caravans parked near the Service Area have been served with legal notices to vacate by Planning Enforcement. The caravans near the Pocklington boundary on the B1246 are on private land.

Highway verges at Keldspring Lane and Sutton Lane – SC and the clerk had an on-site meeting with Grounds Maintenance yesterday. Grass cutting and verge repairs will be carried out in the near future.

Parish update – June issue has been completed.

East Riding Local Plan update – consultation until the 25 June. Members happy with the report, no further observations.

Reports from Pocklington Provincial Councillors:

Devolution between ERYC and Hull CC – DN confirmed that there had been a debate this afternoon, with Devolution being approved and supported by the Pocklington Provincial Councillors. Presently no one can see the full content of the Agreement and the timescale. There will be an election for a Mayor in May 2025.

Planters – DN is waiting for a response from Highways, but will chase once again.

Ashcourt meeting – DN will arrange an Agenda for the meeting with Ashcourt's in the Village Hall on 12 June at 9.00 am. SC and CH will attend.

Grant funding – DN mentioned funding available through Do It for Yorkshire; Blue Token Grants; Tesco Strongest Starts.

A1079 central reservation Beacon - confirmed a light will be installed on the Beacon in the near future.

Matters arising from previous meetings:

Highway verges and footpaths – damage reported at Flat Lane, Holborn Estate and St. Catherine's Church and Keldspring Lane. Highways will review these areas.

Traffic calming measures in Barmby Moor Parish – discussed at the AGM

Play Park – grant application submitted.

Bus Shelters cleaning – parishioner who had shown interest has withdrawn. Clerk advertised in the Parish update.

Planters – already discussed.

A1079 central reservation opposite Kimberley House - Beacon already discussed.

Width of hedge at Keldspring Lane corner – SC has had a word with the homeowner.

D-Day 80 Celebrations – £500 grant application has been successful.

Potholes – repairs have been carried out.

Rough sleepers – no update from the Rough Sleepers Co-ordinator, members unsure if the bus shelters are still being used.

102 Squadron – BE representing the PC at Re-union Dinner, and also laying the poppy wreaths on the Sunday.

Unauthorised Encampments in the parish – in the hands of the Enforcement Officer, Jonathan Cait.

Hire of Village Hall – JG reported there are no vacancies for changing the meeting to an earlier time. Only Thursday, 5 September, is available.

Village Hall installation of new Wi-Fi supplier – members agreed to continue paying 50% towards the monthly costs plus 50% of the installation costs £134.20 = £67.10.

Ashcourt's – proposed meeting about disappearing trees and hedging, already discussed. **Barmby Moor School** – BE had a meeting with GS and DN with suggestions of improving vehicle parking during drop off or pickup times.

Village Hall – JG reported James Smith is the new Chair, and Deborah Anable is the new Lettings Secretary. They have changed banks to the Co-op Bank and the roof needs repairing at a cost of £15,000.
